How Your Information Is Used

We will use your personal identifiable information in the following ways:

- For payment purposes (if applicable) and to provide convenient and targeted support.

We will **NEVER** provide your personally identifiable information to any parties other than a law enforcement or regulatory agency at their request, third parties who provide services on our behalf such as payment processing (if applicable), only if they agree not to miss use this information.

We do not under any circumstances apart from the above give away or sell your information to any third parties.

Your personal information is safe with us, your information is safely encrypted using SSL.

To comply with the Children's Online Privacy Protection Act, services offered on www.mandyvangoeije.com are only available to users who are at least 13 years old. If you are under 13, please do not use www.mandyvangoeije.com.

Cookies

Like any other website, www.mandyvangoeije.com uses 'cookies'.
